



Cooperation Agreement

(for the development, organization and implementation
of the university study courses in Locarno Switzerland)

This Cooperation Agreement is signed between the following Parties:

Introductory notes:

I On November 25th 2016, the Parties signed the Memorandum of Understanding (MoU) for the development and execution of the IUG university study courses in Locarno Switzerland. This MoU defined the general cooperation of the Parties and the commencement of the IUG Medicine university study course in Locarno, Switzerland.

II On December 2nd 2016, International University of Gorazde delivered to Zaklada Europa the Declaration of compliance on the commencement of the academic year 2016/2017 for the Faculty of Health Sciences of the IUG in March 2017. Declaration applies to the IUG university study course in Medicine to be implemented only in Locarno campus (CH).

III Parties agreed to have admission test for the university study courses in Medicine of the IUG in January and February 2017 with the participation of the professor from the IUG.

In relation to the above mentioned the Parties to this Cooperation Agreement hereby agree the following:

A Mutual objective of both Parties is to develop a common program with other universities located in the European Space for Education and Research countries, and to facilitate the process of obtaining double university titles and the movement of the young generations across European Union and European Space for Education and Research countries. To achieve these results, the IUG accepts to sign cooperation agreements with EU Universities indicated by Zaklada Europa and professors coming from the mentioned EU universities to provide lectures, seminars, exams, etc.

B Zaklada Europa shall promote the cooperation agreements of the IUG with other universities in European Union and in European Space for Education and Research countries to facilitate the process under the item A, as well as Zaklada Europa shall promote its agreements with the IUG. IUG shall promote its agreements with Zaklada Europa.

C Parties agree to develop, organize and implement the study university courses in Dentistry, Physiotherapy, Pharmacy and Nursing for academic year 2017/2018 upon the same organizational principle as the university study courses in Medicine are being developed and implemented in the academic 2016/2017 and in the following years in Locarno, Switzerland.

D For the development, organization and implementation of the university study courses under the Item C, Zaklada Europa is to perform the relationship with students in form of tutorship, translation, job placement and other non-academic services to the students. Students are to be enrolled via Zaklada Europa to the International University of Gorazde and Zaklada Europa is to provide to the International University of Gorazde the enrollment fees to be agreed upon. The IUG will require nostrification of documents for foreign students.

E Admission tests and commencement of the university study courses in Dentistry, Physiotherapy, Pharmacy and Nursing for the academic year 2017/2018 will be agreed upon and subject to Annexes of this Cooperation Agreement. In principle, admission tests will start in July 2017 and finish in February 2018 and the university study courses will start in March 2018.

F In relation to this Cooperation Agreement and the Memorandum of Understanding signed on November 25th 2016, Parties acknowledge and accept that their written correspondence and documents exchanged via email, registered post or other business manner shall be considered as official, and shall be governed by the Memorandum of Understanding signed on Nov 25th 2016, and this Cooperation Agreement. The same principle applies to the organization, development and implementation of the university study courses in Medicine.

G International University of Gorazde agrees to participate in marketing, communication, and public relations expenses of the university study courses specified under the Item C, executed in

Europe by Zaklada Europa. Amounts of the participation shall be agreed upon and subject to the Annexes to this Cooperation Agreement. In principle, the IUG will contribute to Zaklada Europa with 1.500 euro per student up to students enrolled per each university study course for each academic year, and with euro per student over enrolled students per each university study course for each academic year, developed, organized and implemented under this Cooperation Agreement for the university study course of Dentistry, and for the university study course of Nursing and Physiotherapy, the IUG will contribute to Zaklada Europa with..... euro per enrolled student, and for Pharmacy the IUG will contribute to Zaklada Europa with euro per enrolled student. Zaklada Europa will pay for each student enrolled in the IUG university study courses for each academic year via Zaklada Europa the same tuition fee fixed by the IUG deducted of the above amounts for participation in marketing, communication and public relations expenses. Tuition fee determined by the IUG for Dentistry amounts to euro for each university study course academic year, for Nursing and Physiotherapy amounts to euros for each university study course academic year, and for Pharmacy amounts to euros for each university study course academic year. Zaklada Europa shall perform the payments of the abovementioned tuition fee(s) to the IUG in two installments, 50% of the tuition fee(s) at the enrollment of the students, and 50% of the tuition fee(s) at the end of the university study course academic year. The same payment method of two installments applies to the university study courses of Medicine regulated by the MoU signed on Nov 25th 2016. Item G is also expressed in the Attachment 1 (excel sheet) to this Cooperation Agreement. Amounts expressed in this Item G shall not be modified for the duration of the university study courses cycle stipulated by this Cooperation Agreement and the MoU of November 25th 2016.

H Zaklada Europa is to cover the expenses for travel, accommodation and meals of the professors coming from the International University of Gorazde to Locarno to join the lectures in the university study courses under the Item C. Professors are to accept to be registered for their lectures, seminars, and all other activities and diffused by online activities provided by Zaklada Europa. Fees paid by the IUG to the IUG full time professors will be in a range between..... euro/h, andeuro/h for assistant professors for the first year Medicine study courses. At the end of February 2017, when the admission test will be finished, the Parties will meet each other to consider the opportunity to integrate these amounts for the IUG professor to come to Locarno.

I All university courses developed, organized and implemented by the IUG and Zaklada Europa in Locarno (CH) shall be conducted in English.

J This Cooperation Agreement becomes effective upon signature of both Parties and lasts for the duration of the university study course plus one year organized under this Cooperation Agreement. It will be automatically renewed, unless either Party expresses its opposition via official written letter with a three-month notice

K Each Party is able to terminate this Cooperation Agreement by sending an official written letter to the other Party at least three months prior to the end of a university study course

academic year. In any case, the IUG shall ensure the continuance of the university study course for the enrolled students.

L This Cooperation Agreement applies to the International University of Gorazde and its potential dislocated departments, as well as to Zaklada Europa and its subsidiaries.

M This Cooperation Agreement may be amended or revised by the two Parties after consultation and mutual agreement. Any issues not mentioned in this agreement may be resolved through mutual agreement.

N Both Parties agree that the up-till now cooperation is conducted in the best business and academic practice.

O Official language of the communication between the Parties is English. All disputes arising out of or in connection with this MoU shall be settled at the Court in Ticino Canton.

P This Cooperation Agreement is made in 4 (four) identical copies, two identical copies remain at each Party.
